

**FIRST AMENDMENT TO THE BY-LAWS
OF THE
COUNCIL OF CO-OWNERS OF KEENE MILL WOODS CONDOMINIUM**

Real Property Code (“RPC”) Numbers Appended as Exhibit B

The COUNCIL OF CO-OWNERS OF KEENE MILL WOODS CONDOMINIUM (“Keene Mill Woods Condominium”) makes this FIRST AMENDMENT to its By-Laws (“By-Laws”) as of this 23rd day of January, 2017.

WHEREAS, Keene Mill Woods Condominium was created by the recordation of a Master Deed in Deed Book 3783 at Page 123 et seq. among the Land Records of the County of Fairfax, Virginia, which also included the recordation of the By-Laws at Book 3783, Page 151 et seq. as Exhibit F to the Master Deed; and

WHEREAS, Section 55-79.71(B), contained in the Condominium Act of the Code of Virginia (“Virginia Condominium Act”), provides that if any units in a condominium are restricted exclusively to residential use and there is any unit owner other than the declarant, the condominium instruments may be amended only by agreement of owners of units to which two-thirds of the votes in the unit owners’ association appertain or such larger majority as the condominium instruments may specify; and,

WHEREAS, Section 55-79.71(D) of the Virginia Condominium Act provides that agreement of the required majority of unit owners to any amendment of the condominium instruments shall be evidenced by their execution of the amendment, or ratifications thereof, and the same shall become effective when a copy of the amendment is recorded together with a certification, signed by the principal officer of the unit owners’ association or by such other officer or officers as the condominium instruments may specify, that the requisite majority of the unit owners signed the amendment or ratifications thereof; and

WHEREAS, units within Keene Mill Woods Condominium are restricted exclusively to residential use and there are units owned by other than the declarant; and,

WHEREAS, Article XV, Section 1 of the By-Laws provides that the By-Laws may be amended by the affirmative vote of members representing three-fourths (3/4ths) of the total outstanding value of the Condominium Project at any meeting of the members duly called for such purpose, and shall become effective only upon the recordation among the Land Records for Fairfax County, Virginia, of an amendment to the By-Laws attached as Exhibit F to the Master Deed setting forth such amendment to these By-Laws and only after thirty (30) days prior written notice to the institutional holders of all first mortgages on the units in the Condominium Project; and

WHEREAS, members within Keene Mill Woods Condominium who hold more than three-fourths of the total outstanding votes have approved, at a duly called member meeting, this First Amendment to the By-Laws, which is acknowledged by the President of Keene Mill Woods Condominium on the attached “Exhibit A”; and

WHEREAS, on December 20, 2016, the Management Agent for Keene Mill Woods Condominium sent written notice of this First Amendment to the By-Laws to the institutional holders of all first mortgages on the units in the Condominium Project.

NOW, THEREFORE, the By-Laws of the Council of Co-Owners of Keene Mill Woods Condominium are amended as follows:

ARTICLE IV, SECTION 5

Article IV, Section 5 of the By-Laws presently reads as follows:

Section 5. Quorum. The presence, either in person or by proxy, of members representing at least a majority of the total value of the Condominium Project shall be requisite for, and shall constitute a quorum for the transaction of business at all meetings of members.

Article IV, Section 5 of the By-Laws is amended by deleting the provision above in its entirety and substituting the following new **Article IV, Section 5**:

Section 5. Quorum. The presence, either in person or by proxy, of members representing at least 10 percent of the total value of the Condominium Project shall be requisite for, and shall constitute a quorum for the transaction of business at all meetings of members.

Except as herein expressly modified, the By-Laws are hereby ratified, confirmed and republished.

IN WITNESS WHEREOF, Keene Mill Woods Condominium, with the requisite assent of the members, has caused this First Amendment to the By-Laws to be executed pursuant to due and proper authority as of the date first set forth above.

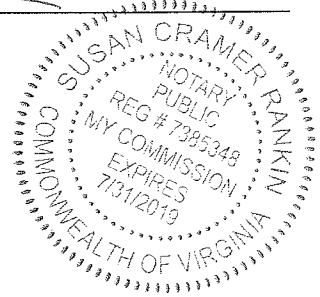

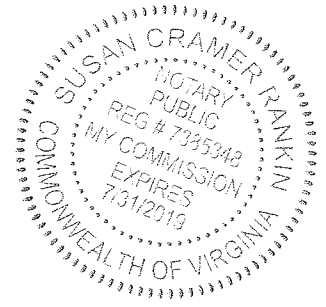
